Chief's Report – Fire Chief Dan Orr reported:

- New Hires are all status Quo.
- ILA for Fire Code Technician has been sent to legal for review and back to City Managers.
- Updated Strategic Plan and will add to website.
- Rezoning paperwork submitted to the County for Sieberts Creek Property, an offer has been made on the Anderson Road property and a special meeting is scheduled for Station 36 on October 9th, 2023, regarding the fate of that property.
- Applications are due on October 15th, 2023, for the Fire Chief position.
- Staff attended a meeting regarding Towne Road connectivity.
- Staff have been working with the City of Sequim regarding a movie premier in December; this may be moved to Deer Park Cinemas; more information will be forthcoming as available.
- Olympic Ambulance is working on a performance-based contract with the District; more information will be forthcoming when a draft of the contract is received.

Deputy Chief's Report – Deputy Chief Tony Hudson reported:

 Negotiated items being addressed at this time are: Mandatory Modifications, Position for Position fillings and K-Day selections.

- Captain Swanberg continues to work on Telestaff rebuild.
- Conditionals Use Permit for the training grounds was submitted on September 29th, 2023; waiting to hear back from the county at this time.
- The station 33 bathrooms project is progressing, framing is underway currently.
- General Contractor RFP is being prepared for Station 34 patio/kitchen.
- Brush Truck Chassis has been ordered; this project will go into 2024.
- New engine pre-construction meeting will be held in two weeks in Sequim.
- New F-150 pickup trucks are in at the dealer in Vancouver and are waiting on canopies; these should arrive after the first of the new year.

REGULAR BUSINESS

Agenda Bill 1: 2022 State Auditor Officer - Exit Conference —During the online Teams meeting with the Washington State Auditor's office, Jim Jones, Audit Lead and Amy Strzalka, CPA, Program Manager, highlighting that the upcoming published audit reports would cover the Accountability Audit and Financial Statements for the year 2022. The Audit, in brief, that was everything they reviewed was in order. There were two minor corrections that were immediately addressed and resolved. They commented that Finance Manager Alwyn Whitaker was a pleasure to work with and the District is compliant with their standards. INFORMATION ONLY; NO ACTION WAS TAKEN.

Agenda Bill 2: 2024 Draft Budget – Finance Manager, Alwynn Whitaker, presented the proposed budget. There were discussions about many line items; Commissioners asked staff to research alternatives for the Ground Maintenance Position, as well as the Administration Assistant Position. They would like staff to research the possible outsourcing of some of the administration tasks as well as the possible elimination of some of these tasks. Commissioners agreed to return the costs of Cancer Screening back into the budget. INFORMATION ONLY; NO ACTION WAS TAKEN.
