The focus of the Workshop is determining the direction the Commissioners want the district to go based on the changes in leadership roles with the addition of Battalion Chiefs. **Agenda Bill 4: Letter of Support of Emergency Operations Center and Dispatch** – Staff submitted a letter of support for the construction of a consolidated EOC and Dispatch building. Commissioner Miano moved and Commissioner Nicholas seconded approval of Resolution 2023-01 for 23-01 Budget Amendment of \$30,000 to help fund Captain Cate's Memorial.
