Agenda Bill 1: Landscape Maintenance – Chief Orr reached out to Jamestown regarding their interest in providing lawn services for ST 37. Jamestown informed him that they utilize an external company named Envious Greens. Chief Orr contacted Envious Greens and obtained an initial quote of \$3,240 for mowing and weed whacking for the entire year of 2024. Additionally, bark and landscape maintenance were offered as optional services at an additional cost of \$500 for the year. Commissioner advised Chief Orr to proceed with negotiating a contract for ST 37 lawn maintenance services with Envious Greens for the year 2024. **INFORMATION ONLY, NO ACTION**
