REGULAR BUSINESS

Agenda Bill 1: Community Paramedic Program – BC Jones and Captain Konopaski provided a comprehensive presentation on Community Paramedicine, highlighting key points such as emphasizing that the Labor group's interested in the program, discussing the structure of other community paramedicine programs locally and outlined how the District's program would need to be organized, with a particular focus on having a District member serve as the navigator for the program, and noting that the National Registry recognizes Community Paramedicine as a standalone certification. Current members interested in taking on this role would undergo certification through established programs. Commissioner Mingee expressed appreciation to BC Jones and MSO Konopaski for their presentation. Commissioner Mingee acknowledged the support of the current Board, stating that they are not afraid to take chances and are highly supportive of trying the Community Paramedicine program.
