Chief's Report – Fire Chief Dan Orr reported:

- Three of the probationary firefighters will be going to the Washington State Fire Academy in January.
- Staff are still waiting for the cities to finalize their budgets to see if a shared full-time fire prevention employee will be approved.
- The "Boys in the Boat" movie premier is to be held on 12/8/2023 at the Deer Park Cinemas; this production is much less of an ordeal than originally believed to be. CERT will be helping with parking logistics because they will be transporting citizens from Sequim to the theatre and back.

- Olympic Ambulance dedicated unit trial is underway. Members can see unit availability using mobile and the CrewForce App.
- Home Depot and our staff have collaborated to clarify response expectations, addressing
 concerns about blocked entrances during the holidays. The aim is to deter break-ins and theft,
 although these barricades pose a challenge for incident response.
- Commissioners asked that the Districts Facebook page have comments removed and staff report, that has been done. This was done to keep up with recommendations for best practices to protect the District's social media outlets.
- Staff have reached out to the person the Mechanic position was offered to and were assured that a February 1st start date should be able to be achieved.
- January 12th, 2024 marks the 1-year anniversary of Captain Cate's passing. Staff are working on an event to honor this anniversary.
- The Finance Manager position will close 12/11/2023; at this time, there is one applicant.
- Staff are actively engaged in securing a USDA Grant with the goal of obtaining nearly \$500,000. This grant is intended to supplement budgeted costs for apparatus replacements.

Deputy Chief's Report – Deputy Chief Tony Hudson reported:

- Staff are researching options to re-chassis Tender 33 that was previously surplussed by the Board. A new Tender is roughly \$600,000 and staff believe that this would be a way better route to go financially.
- Telestaff auctions for line staff are underway, Captain Swanberg has been keeping a close eye on this and he and DC Hudson will double check everything when the first round of auctions are complete.
- Conditional Use Permit (CUP) for TOC is complete.
- A Brush Truck box and chassis and two Engines have been ordered. Staff went to South Dakota on November 2nd for a pre-build meeting for the Engines.
- IT Staff are attending a Security Awareness Training coming up.
